The starter battery is ready for use and intact. Should this not be the case, a new battery will be installed and billed at usual garage rates together with the procurement costs. MOTOR AUCTIONS ensures complete insurance coverage for the Consignor as of the moment of vehicle handover. MOTOR AUCTIONS is granted a 5-day post-sales period by the Consignor without price reduction. In the event of non-sale, a storage fee of 50 euros per day shall be incurred as of day 7.

By signing this contract, the Consignor binds the Consignor's vehicle to this auction of MOTOR AUCTIONS. If a technical defect is found leading to a significant reduction in the value of the vehicle, the vehicle can be withdrawn without charge. Should the Consignor withdraw the vehicle without due justification at the time the catalogue is published, the amount equaling the buyer's premium to the estimate must be paid.

By signing this contract, the Consignor undertakes to remove the vehicle from all listings and publications in print and electronic media and transfer all marketing rights up to the auction to MOTOR AUCTIONS. This contract is only valid with completely filled out detailed information about the vehicle (see appendix) and 25 detailed and relevant photos in good quality. All publication rights of these photos are thereby transferred to MOTOR AUCTIONS. In addition, MOTOR AUCTIONS expects to receive a copy of all vehicle documents by mail or scanned via email.

If any provision of this contract should prove to be invalid or unenforceable directly or in the future, all other provisions of this contract shall remain unaffected thereby. The same shall apply to filling any gaps in this contract.
